CHAPTER 276.**BISHOP OF FREETOWN AND BO AND APOSTOLIC
PREFECT OF MAKENI INCORPORATION.**

An Ordinance for the re-establishment of the Bishop of Freetown and Bo under the corporate name of Bishop of Freetown and Bo and for the incorporation of the Roman Catholic Apostolic Prefect, Makeni, under the corporate name of Apostolic Prefect of Makeni.

WHEREAS by virtue of the Bishop of Freetown and Bo Incorporation Ordinance, 1952, the expression "Bishop of Freetown and Bo" was enacted to mean the Bishop of the Roman Catholic Church in Sierra Leone and all property held by the Vicar Apostolic of Sierra Leone was vested in the Bishop of Freetown and Bo:

AND WHEREAS on the 3rd day of April, 1952, the Roman Catholic Diocese of Freetown and Bo was divided to give effect to the creation of the new Apostolic Prefecture of Makeni:

AND WHEREAS it is expedient to give effect to the establishment of two Roman Catholic bodies corporate within Sierra Leone, each distinct from the other, where before there had been one:

AND WHEREAS it is also expedient to provide for the re-establishment of the Bishop of Freetown and Bo, to incorporate the Apostolic Prefect of Makeni as a separate legal entity and to vest in the said Apostolic Prefect of Makeni all property proper to that Prefecture.

1. This Ordinance may be cited as the Bishop of Freetown and Bo and the Apostolic Prefect of Makeni Incorporation Ordinance. Short title.

2. The expression " Bishop of Freetown and Bo " means the Bishop of the Roman Catholic Diocese of Freetown and Bo. Interpretation.

3. The Bishop of Freetown and Bo shall be a body corporate with perpetual succession and the corporate name of " Bishop of Freetown and Bo ", and he and his successors shall have full power and authority in the said corporate name to sue, and be sued, and to acquire and hold property, both real and personal, and to sell, mortgage, alienate or lease the said property. 4. The Apostolic Prefect of Makeni shall be a body corporate with perpetual succession and the corporate name of " Apostolic Prefect of Makeni ", and he and his successors shall have full power and authority in the said corporate name to sue, and be sued, and to acquire and hold property, both real and personal, and to sell, mortgage, alienate or lease the said property. Apostolic Prefect of Makeni a body corporate.

5. (1) The Bishop of Freetown and Bo may have, and use, a corporate seal, and may, from time to time, break, alter, or renew the same. Corporate seal.

(2) The Apostolic Prefect of Makeni may have, and use, a corporate seal, and may, from time to time, break, alter, or renew the same.

6. (1) Subject to the provisions of sub-section (2) of this section all property, rights or privileges vested in and all obligations and liabilities binding upon the Bishop of Freetown and Bo as a body corporate at the date of commencement of this Ordinance shall continue to vest in or be binding upon the said Bishop of Freetown and Bo. Property and liabilities.

(2) With respect to the Northern Province of Sierra Leone, all property rights or privileges vested in, and all obligations and liabilities binding upon the Bishop of Freetown and Bo as a body corporate whether by virtue of the Bishop of Freetown and Bo 9 of 1952.

Incorporation Ordinance, 1952, or otherwise at the date of commencement of this Ordinance shall vest in or be binding upon the Apostolic Prefect of Makeni as a body corporate as constituted by this Ordinance.

7. Nothing in this Ordinance shall be deemed to affect the rights of Her Majesty, Her heirs and successors, or of any other person.
