An Ordinance for vesting certain lands in the Colony of Sierra Leone belonging to the Church Missionary Society for Africa and the East in the Sierra Leone Church Committee.

[3RD JULY, 1905.]

Preamble.

WHEREAS the Church Missionary Society for Africa and the East (hereinafter called the Church Missionary Society) has for several years past been carrying on missionary work in the Colony of Sierra Leone and its Protectorate, and as such has become the owner of various lands situate in the Colony and Protectorate, on which churches, schools and mission houses have been built for the purpose of carrying on missionary work:

AND WHEREAS the lands aforesaid are held in trust for the Church Missionary Society by an association called the Church Missionary Trust Association, which was incorporated and registered in England in the month of May, 1885, under the Companies Acts, 1862 to 1883, and was empowered (*inter alia*) to hold lands of the Church Missionary Society:

AND WHEREAS for many years past the Church Missionary Society have from time to time withdrawn from portions of their

missionary work in Sierra Leone, and the same has been undertaken and carried on by members of the Church of England in Sierra Leone, known as the Sierra Leone Native Church, on behalf of the Church Missionary Society:

AND WHEREAS an association of members of the Church of England in Sierra Leone, known as the Sierra Leone Church Committee, was by virtue of an Ordinance passed by the Legislative Council of this Colony on the 24th day of November, 1876, and intituled "An Ordinance to incorporate the Sierra Leone Church Committee," incorporated and empowered (*inter alia*) to hold land situate in this Colony not exceeding in yearly value the sum of ten thousand pounds sterling in trust for the Church of England in Sierra Leone (now known as the Sierra Leone Native Church aforesaid):

AND WHEREAS the Church Missionary Society, by a resolution passed on the ninth day of November in the year of our Lord one thousand nine hundred, has resolved to convey absolutely to the Sierra Leone Native Church all the lands of the Church Missionary Society set out in the Schedule to this Ordinance which are now vested in the Church Missionary Trust Association:

AND WHEREAS the Sierra Leone Native Church have agreed to take and hold the said lands to and for the purposes of the Church of England in Sierra Leone, and have appointed the Sierra Leone Church Committee to be their trustees in that behalf:

AND WHEREAS, in order to avoid the great expense that will be incurred in conveying so many different estates from the Church Missionary Trust Association to the Sierra Leone Church Committee, the Sierra Leone Church Committee have, on behalf of the Church Missionary Society and the Sierra Leone Native Church, presented a petition to the Governor praying that the lands described in the Schedule hereto may be vested by an Ordinance of this Colony in the Sierra Leone Church Committee in trust for the Sierra Leone Native Church:

AND WHEREAS the land described in the Schedule hereto with lands now held by the Sierra Leone Church Committee do not exceed in yearly value the sum of ten thousand pounds sterling:

AND WHEREAS it is expedient to grant the prayer of the Sierra Leone Church Committee.

1. This Ordinance may be cited as the Church Missionary Short title. Society Lands Ordinance.

2. All the estate, right, title, interest, claim and demand of the Church Missionary Trust Association or of the Church Missionary Society in all those pieces or parcels of land described in the Schedule to this Ordinance, together with all churches, chapels, schools and other buildings and fixtures erected thereon, and all books, papers, documents, furniture and articles, the property of the Church Missionary Society, belonging and appertaining thereto, and all easements, rights, advantages and appurtenances whatsoever to the said hereditaments appertaining or with the same or any part thereof now or heretofore held, used or enjoyed, or reputed as part thereof, or appurtenant thereto, are hereby transferred to and vested in the Sierra Leone Church Committee to and for the uses or purposes of the Church of England in Sierra Leone.



3. All contracts, covenants and agreements heretofore made or entered into by any person or persons whomsoever with the Church Missionary Trust Association, or any person or persons on their behalf as to or concerning the lands described in the Schedule hereto, shall be deemed and taken to have been made or entered into with the Sierra Leone Church Committee, and shall be executed and enforced by the Sierra Leone Church Committee in the like manner as if the Sierra Leone Church Committee had originally been party thereto instead of the Church Missionary Trust Association, and all proceedings whatsoever which have been, or might, or may have been commenced, taken or done in the name of the Church Missionary Trust Association on behalf of the Church Missionary Society shall and may be commenced, continued, taken or done in the name of the Sierra Leone Church Committee in like manner (in the case of proceedings already commenced, taken or done) as if the Sierra Leone Church Committee had originally been party thereto instead of the Church Missionary Trust Association.

4. For the purposes of this Ordinance the Sierra Leone Church Committee shall be constituted in the manner provided in the Articles of Constitution approved by the Revision Committee of the Church in Sierra Leone, published and issued by the secretaries of the Church Missionary Society upon the Thirtieth day of January in the year of Our Lord one thousand eight hundred and ninety.

A copy of the said Articles and any alterations or amendments made thereto, signed by the President of the Sierra Leone Church Committee, shall be deposited, registered and kept in the office of the Registrar-General, and a copy of the said articles when



duly certified by the Registrar General shall be conclusive evidence thereof in any Court of law.

5. Nothing herein contained shall affect or be deemed to affect in any manner or way the rights of Her Majesty the Queen, Her heirs or successors, or of any body politic or corporate, or of any other person or persons, except such as are mentioned in this Ordinance and those claiming by, from or under them.

Saving of rights of the Crown, bodies politic and other persons.

SCHEDULE.

FREETOWN.

1. All that piece or parcel of land, measuring 75 feet in breadth and 75 feet in depth, containing one town lot and a half of land, and numbered 5 in the register and plan of the Nova Scotian allotments of land situate and being on the eastern side of Kissy Road, Freetown, commencing on the south-western corner of premises now or lately in the possession or occupation of John Langley Grant, and whereon is erected the parsonage attached to Holy Trinity Church.

2. All that piece or parcel of land situate, lying and being on the north side of Kissy Road in Freetown aforesaid, the north-western corner of the said lot commencing at the distance of 480 feet from the first block line of the Nova Scotian allotments in the direction of Kissy Road on the left going to Kissy Village, and having a frontage towards the said road of 82 feet wide, and a rear or depth from the said road of 132 feet, being a portion of Lot No. 4 in the register and plan of the allotments of land made to the first Nova Scotian settlers, and whereon is erected the edifice commonly called Holy Trinity Church.

3. All that piece or parcel of land situate in Fourah Bay Road, Freetown, being portion of that piece of land numbered 4 in the register and plan of the Nova Scotian allotments.

4. All that piece or parcel of land measuring 65 feet in breadth, and 15 feet in depth, being part of that piece or parcel of land situate in Fourah Bay Road in Freetown aforesaid numbered 4 in the register and plan of allotments of land made to the Nova Scotian settlers and abutting upon the lot numbered 5 in the register and plan aforesaid.

5. All that piece or parcel of land, measuring 142 feet by 74 feet wide, being portion of that piece of land situate in Fourah Bay Road in Freetown aforesaid, numbered 5 in the register and plan of the Nova Scotian allotments of land for Freetown aforesaid, adjoining on the south end of the lot formerly occupied by the Church Missionary Society numbered 4 in the register and plan aforesaid.

6. All that piece or parcel of land, situate in Kissy Road in Freetown aforesaid, in the seventh block of the first Nova Scotian allotments of land, being at a distance of 238 feet from Kissy Road, having a frontage to the seventh block line of 75 feet, and a rear or depth of 75 feet, bounded on the west by the seventh block line, and on the east, north and south sides thereof by land now or lately the estate of Isaac Fitzjohn, deceased, the same being

portion of the land numbered 212 in the public register and plan of the said allotments, and fully described in a deed of conveyance dated the 30th day of May, 1872, between the said Isaac Fitzjohn and one J. A. Lamb, and registered in volume 21 of conveyances, page 458, in the office of the Registrar-General of the Colony aforesaid.

7. All that lot of land situate in Pademba Road, formerly called Portuguese Town Road, Freetown, and numbered 1 in the public register and plan of town lots of land for Freetown aforesaid.

8. All those four town lots of land situate, lying and being in Pademba Road and Soldier Street in Freetown aforesaid and numbered in Pademba Road 52 and 53, and in Soldier Street 94 and 96 in the register and plan of town lots of land for Freetown aforesaid.

9. All those two portions, pieces or parcels of land measuring respectively 11 feet in breadth and 50 feet in depth, and being respectively parts of those pieces or parcels of land situate in Circular Road numbered respectively 49 and 50 in the said register and plan of town lots of land for Freetown aforesaid.

ABERDEEN.

1. All that piece or parcel of land situate at the corner of Cromwell Street and Watson Street in the village of Aberdeen bounded on the north by land in the possession of Charlotte Warne, 105 feet; on the south by Cromwell Street aforesaid, 105 feet; on the east by Watson Street aforesaid, 73 feet; and on the west by land in the possession of G. Shyllon, 70 feet; on which said land the church is built.

2. All that piece or parcel of land situate, lying and being at the corner of Cromwell Street and Watson Street, in the village of Aberdeen, and bounded on the north by Cromwell Street aforesaid, 103 feet; on the south by land in the possession of Nancy Taylor, 103 feet; on the east by Watson Street aforesaid, 97 feet; and on the west by land in the possession of George Matthews, 100 feet; on which said land the school is erected.

ALLEN TOWN.

1. All that piece or parcel of land situate in Allen Town, in the Colony of Sierra Leone, fronting the public street, bounded on the outside by property of John Leigh, and on the other side by property of John Bradshaw, being 111 feet long and 100 feet broad, on which the church in memory of St. John Baptist at Allen Town aforesaid is built, and described in a deed of conveyance, dated 14th July, 1873, from Samuel King to the secretaries of the Church Missionary Society.

2. All that piece or parcel of land situate, lying and being in Allen Street, Allen Town aforesaid, and bounded on one side by land the property of John Leigh, 396 feet; on the other side by land the property of Phœbe Williams, 396 feet; and measuring on the frontage towards the said street 158 feet.

DUBLIN, BANANAS.

1. All that piece or parcel of land situate at Dublin, on the Bananas Island, and numbered 924 for the purpose of taxation, measuring on the north 66 feet, on the east 66 feet, on the south 68 feet, on the west 73 feet, bounded on the north by Wilmot Street, on the east by a street unnamed, on the south by land said to be in the possession of Samuel Nylander, and on the west by a lot said to be in the possession and occupation of Moses Terry.

2. All that piece or parcel of land situate, lying and being in Wilmot Street, in the village of Bananas, in the Waterloo District of this Colony, being the grounds upon which the church and school of Mark's Parish are built, bounded on the east by Wilmot Street aforesaid, 191 feet; on the west by James Street aforesaid, 191 feet; on the north by an open ground, 134 feet; on the south, by where the belfry is fixed, 134 feet.

3. All that piece or parcel of land situate at Wilmot Street aforesaid, and bounded on the east by land in the possession and occupation of some person or persons unknown, 66 feet; on the west by the said Wilmot Street, 66 feet; on the north by Crown land, 66 feet; and on the south by land in the possession of Adeline Johnson as to part and occupied by the police station as to the remainder, 66 feet.

BATHURST.

1. All that lot of land in the parish of Saint James at the village of Bathurst, numbered 16 in the register and plan of lots of land for that district, and described in a Crown grant, dated 1st July, 1835, and registered in the office of the Registrar-General.

2. All that piece or parcel of land situate, lying and being in King William Street, on the road leading from Freetown to Charlotte, in the united Parishes of St. Peter and St. James, in the town which is now commonly called Bathurst, but which was formerly known by the name of Leopold, in the Police District of Freetown, and bounded by a right line which runs from the corner of St. Peter's Street northward on the aforesigned King William Street, to the extent of 248 feet, thence proceeds westwards along the north side, in a right line and at right angles to the last line to the extent of 182 feet, and bounded by the premises of the Church Missionary Society, thence turning in a southern direction along the western side runs in a line parallel to King William Street until it reaches St. Peter's Street aforesaid, thence bounded by St. Peter's Street on the south side until it again reaches the afore-named King William Street and described in a Crown grant, dated 27th November, 1847, and registered in the office of the Registrar-General.

3. All that piece or parcel of land situate, lying and being at the corner of Mends Road and George Street, in the village of Bathurst, on which the church, school and house now occupied by the schoolmaster are built, and bounded on the north by land of Mammy Garnon, 360 feet; on the south by George Street, 383 feet; on the east by land belonging to Mr. King and Mr. Matthews respectively, 320 feet; and on the west by Mends Road, 290 feet.

BENGUEMA.

All that lot, piece or parcel of land situate, lying and being in Liverpool Street, in the village of Benguemá, on which the church, school and parsonage are built, and bounded on the north by land in the possession of Mr. Hamilton, 1,400 feet; on the south by land in the possession of Mr. Savage, 1,385 feet; on the east by unoccupied lands, 250 feet; and on the west by Liverpool Street aforesaid, 220 feet.

CAMPBELL TOWN.

All that piece or parcel of land situate, lying and being in Campbell Street, in the village of Campbell Town, and bounded on the north by land in the possession of Agabus Johnson, 115 feet; on the south by Campbell Street aforesaid, 115 feet; on the east by land in the possession of Mary Williams, 115 feet; and on the west by land in the possession of Mr. Johnson, 115 feet, on which the church is erected.

CHARLOTTE.

1. All that lot, piece or parcel of land situate, lying and being on the left side or south side of a road leading from Bathurst to the house heretofore called the "Government House," and bounded on the north by a running stream, 130 feet; on the south by the said road, 128 feet; on the east by land in the possession of Richard Fyne, 230 feet; and on the west by land in the possession of Emanuel Taylor, 220 feet; on which said land the school is built.

2. All that stone building situate on the right hand or north side of a road leading from Bathurst to the house heretofore called the "Government House," as represented in a plan attached to a Crown grant, dated 27th November, 1847, and registered in the office of the Registrar-General, which said stone building is the church of the Parish of Saint John, in the village of Charlotte, in the Police District of Freetown, used as a place of public worship.

GLOUCESTER.

1. All that piece or parcel of land situate and being in High Lane Street and between Ridley Street and Too Good Street, in the village of Gloucester, and bounded on the north by Too Good Street, 230 feet; on the south by Ridley Street, 215 feet; on the east by land belonging to Mr. Forster and Sally Horton respectively, 245 feet; and on the west by High Lane Street, 236 feet; on which said land the parsonage is built.

2. All that triangular piece or parcel of land situate in the Parish of Saint Andrew, in the village of Gloucester, in the Colony of Sierra Leone, containing two rods fifteen perches, bounded on the north and west by High Street, and on the south by Cross Street, and on the south-east by Church Street, and as shown in a diagram in the margin of a Crown grant, dated 27th February, 1843, and registered in the office of the Registrar-General.

GODERICH.

1. All that piece or parcel of land situate, lying and being at the corner of Lorient Street and Somers Street, in the village of Goderich, and bounded on the south by Lorient Street aforesaid, 110 feet; on the north by land in the possession of James Gubber, 110 feet; on the east by Somers Street aforesaid, 150 feet; and on the west by land in the possession of the "Huntingdon Church," 140 feet; on which the mission house is built.

2. All that piece or parcel of land situate, lying and being at the corner of Lorient Street and Hamburg Street, in the village of Goderich, and bounded on the north by land in the possession of P. Lee, 110 feet; on the south by Hamburg Street aforesaid, 110 feet; on the east by land in the possession of Solomon Coker, 100 feet; and on the west by Lorient Street aforesaid, 107 feet; on which the church is erected.

GRAFTON.

All that piece or parcel of land situate, lying and being at the corner of Hulket Street and Graf Street in Grafton, and bounded on the north by lands in the possession of Mary King and Robert King respectively, 180 feet; on the south by Hulket Street aforesaid, 180 feet; on the east by land in the possession of Peter Truman, 112 feet; and on the west by Graf Street aforesaid, 112 feet; on which said land the church and school are erected.

HASTINGS.

1. All that piece or parcel of land situate and being between St. Thomas Street and Lord Street, in the village of Hastings, on which the school is built, and bounded on the north by Lord Street, 193 feet; on the south by St.

Thomas Street, 208 feet; on the east by lands belonging to Messrs. W. V. Coker, Vincent and Cole respectively, 400 feet; and on the west by lands belonging to Messrs John Coker, Smith and Green respectively, 400 feet.

2. All that lot of land situate in Church Street, in the parish of St. Thomas, in the town or village of Hastings in the Waterloo District, contiguous to the land on which the church is built, and bounded on the west by a continuation of the eastern side of Church Street aforesaid in a northerly direction from the land on which the church is built to the distance of 132 feet, on the north by Market Square to the distance of 150 feet to the eastward, on the east by a line running at right angles from Market Square in a southerly direction to the distance of 232 feet, where it bisects the southern boundary which runs westerly and meets the said land on which the church is built and described in a Crown grant dated 18th July, 1844, and registered in the Registrar-General's office.

3. All that lot of land in the village of Hastings, in the Waterloo District of the Colony of Sierra Leone, situate on the south-western side of the road leading from the Market Square to the Parsonage at the distance of two chains from the north-eastern angle to the southern-most square, and admeasuring in continuation of the said southern line 100 feet frontage, and 75 feet depth, whereon the Parish Church is built and described in a Crown grant dated 4th May, 1888, and registered in the office of the Registrar-General.

4. All that piece or parcel of land situate at the west end of Church Street, in the Parish of St. Thomas, in the village of Hastings aforesaid together with the building erected thereon, and formerly known as "Government or Manager's House," which said land extends in a right line with the front and from the corner of the said house on the south side of the road which runs at right angles southward of Church Street to the extent of 314 feet, thence bounded by a straight line which runs at right angles westward to the extent of 522 feet, and thence runs at right angles to the above and last-mentioned line northward, and in a line parallel with the aforesigned house, 542 feet, and thence again runs westward in a right line and at right angles to the last named line until it again meets the aforesigned "Government or Manager's House" at the north-west corner, and described in a Crown grant dated 22nd February, 1848, and registered in the office of the Registrar-General.

KAKANDA TOWN.

All that lot, piece or parcel of land situate and being in Campbell Town Road, in the village called Kakanda Town, and bounded on the north by unoccupied land, 125 feet; on the south by Campbell Town Road, 123 feet; on the east by land in the possession of Mr. Davies, 180 feet; and on the west by land in the possession of Mr. Davies, 180 feet.

KENT.

1. All that piece or parcel of land situate, lying and being in Dance Street, in the village of Kent, in the Waterloo District of this Colony, being the site on which the church is built, and bounded on the east by the said Dance Street, 132 feet; on the west by Government Yard, 132 feet; on the north by Saint George's Street, 141 feet; on the south by Government Yard, 141 feet.

2. All that other piece or parcel of land situate, lying and being in Dance Street, and bounded on the east by Dance Street, 132 feet; on the west by Government Yard, 132 feet; on the north by Dublin Street, 141 feet; and on the south by Saint George's Street, 141 feet.

KISSY.

1. All that piece or parcel of land situate, lying and being in the middle of Third Street, in the Parish of Saint Patrick, in the town or village of Kissy, whereon is erected the Parish Church, and bounded on the east and west by Third Street aforesaid, on the north by a road leading to Freetown, and on the south by land attached to the hospital at Kissy aforesaid, and described in a Crown grant dated 27th November, 1847, and registered in the office of the Registrar-General.

2. All that lot of land in the village of Kissy aforesaid, numbered 51 in the register and plan of lots of land for that village and described in a Crown grant dated 1st July, 1833, and registered in the office of the Registrar-General.

3. All that piece or parcel of land situate and being in Blackhall Road, in the village of Kissy aforesaid, and bounded on the north by Blackhall Road, 276 feet; on the south by lands of Messrs. Wilson and Barber respectively, 343 feet; on the east by land on which Belmont House is erected, 447 feet; and on the west by a lane 462 feet; on which said land "The liberated African School" is built.

LEICESTER.

All that piece or parcel of land situate, lying and being at the main street called "New London Road" of the village of Leicester, and bounded on the east by lands formerly in the possession or occupation of Rebecca Peters, on the west by lands in the possession of Jeconiah Claudius King, on the north by the said New London Road, and on the south by the brook called "Man Water," having a frontage on the said New London Road of 66 feet, and a rear or depth extending down to the said brook, on which said lands are erected the church and school of the Parish of Saint Andrew.

LUMLEY.

All that piece or parcel of land situate, lying and being at the corner of Regent Road and Goderich Road, in the village of Lumley on which the Church is built, bounded on the north by Regent Road, 145 feet; on the south by land the property of Mr. Watts, 133 feet; on the east by unoccupied lands, 112 feet; and on the west by Goderich Road, 132 feet.

MACDONALD.

1. All that piece or parcel of land situate and being in Kent Road, in the village of Macdonald, on which the Mission House is erected, and bounded on the north by land in the possession of Patience Cole, 175 feet; on the south by land in the possession of Ishmael Coker, 175 feet; on the east by Kent Road, 170 feet; and on the west by unoccupied lands, 170 feet.

2. All that piece or parcel of land situate in Kent Road, in the village of Macdonald aforesaid, on which the church is built, and bounded on the north by land in the possession of Ann Johnson, 118 feet; on the south by land in the possession of George Rayner 120 feet; on the east by unoccupied lands, 175 feet; and on the west by Kent Road, 172 feet.

MATINDI.

1. All that lot, piece or parcel of land situate, lying and being in Matindi Street, in the village of Matindi, and bounded on the north by Matindi Street aforesaid, 100 feet; on the south by unoccupied lands, 100 feet; on the east by land in the possession of H. Macaulay, 380 feet; and on the west by land in the possession of Uriah Coker, 380 feet.

2. All that piece or parcel of land situate, lying and being in Matindi Street, in the village of Matindi aforesaid, and bounded on the north by unoccupied lands, 310 feet; on the south by Matindi Street, 212 feet; on the east by land in the possession of Jacob Martins and the cemetery respectively, 620 feet; and on the west by land in the possession of one Yandebo, 630 feet; on which the church and mission house are erected.

MIDDLE TOWN.

1. All that piece or parcel of land situate, lying and being in the village of Middle Town, on which the mission house is erected, and bounded on the north by land in the possession of Peter Cole, 200 feet; on the south by land in the possession of Benjamin Jones, 200 feet; on the east by the highway, 166 feet; and on the west by unoccupied lands 170 feet.

2. All that piece or parcel of land situate, lying and being in Waterloo Road, in the village of Middle Town aforesaid, on which the church is erected, and bounded on the north by unoccupied lands, 360 feet; on the south by land in the possession of Mr. Dougan, 360 feet; on the east by unoccupied lands, 130 feet; and on the west by Waterloo Road aforesaid, 130 feet.

REGENT.

All that piece or parcel of land situate, lying and being in the Parish of Saint Charles, Regent, bounded on the northern and eastern sides by Hog Brook, commencing and terminating by the bridges marked A and B, as appears by the plan to a Crown grant dated 18th October, 1838, and registered in the office of the Registrar-General, and on the southern and western sides by the road leading from the bridge A to B, being the road to Bathurst, as shown in the said plan, containing 7 acres 14 poles, more or less.

RUSSELL TOWN.

All that lot, piece or parcel of land situate and being in West Street in the village of Russell, bounded on the north by land in the possession of Mr. Doherty, 450 feet; on the south by land in the possession of Mr. Gordon, 450 feet; on the east by West Street aforesaid, 350 feet; and on the west by the mountain; on which said land the church and school are built.

SHERBRO.

Bonthe.

All that piece of land situate in Sherbro, known and numbered on the official plan as No. 85, containing 36 town lots, situate in Heddle Road in the town of Bonthe, and bounded on the north by Monument Lane, on the south by lot numbered 2, on the east by Heddle Road aforesaid, and on the west by Victoria Road, and having a frontage in Heddle Road of 196 feet and a depth of 900 feet, and described in a Crown grant dated 18th January, 1873, and registered in the office of the Registrar-General.

Bendu.

1. All that lot, piece or parcel of land situate, lying and being in Bendu, Sherbro, on which the church is built, and bounded on the north by unoccupied
